proposals for and providing basic infrastructure such as classroom, labs, equipment for facilitating workshops, trainings, seminar, etc. to THE FIRST PARTY.

- 3. The structure of the courses to be offered will be as follows:
  - a. Broad based basic training in number of skill areas related to the sector as per the curricula MSBTE/ DTE.
  - b. Short term modular courses would be offered offer the broad based training. for the next 6 months as per the curricula approved by the MSBTE/DTE.
  - c. Advanced & industrial approach based training in the last quarter.
